Changes to variations AF01 submitted for AF-Air France

AF-01

The following snub-nosed breeds (and their crossed breeds) will not be accepted for carriage:

- American Bully
- English Bulldog
- French Bulldog
- Boston Terrier
- Pugs

Exceptions may be granted by DZIN Product Engineer Live Animals.

Changes to variations CX13-15 submitted for CX-Cathay Pacific Airways

CX-13 ~~Enhanced~~ Endangered species, listed under CITES Appendix I will not be accepted for carriage. This applies to products and parts thereof.

CX-14 The following items will not be accepted for carriage:

Ivory and ivory-related products

All hunting trophies are not accepted for carriage (including legally hunted or legally acquired trophies)

Fins of all sharks and rays
 Rhino horn and Rhino horn-related products
 Tiger pelts, bones and its related products

CX-15 The following information must be clearly provided on the Master Air Waybill:

- 24-hour emergency contact name and telephone number
- ~~Only Single temperature requirement~~ Appropriate temperature range
- If Electronic Monitoring Devices (EMD) are included in the shipment, specify the brand and model of Cathay Pacific-approved EMD in the 'Handling Information' field.

Changes to variations LH02 and LH05 submitted for LH-Lufthansa

LH-02 Endangered species, listed under CITES Appendix I in Chapter 6, will only be accepted if ~~both~~ either the shipper ~~and or the~~ consignee ~~are is~~ members of the organizations WAZA, EAZA or VDZ and are subject to approval by a Lufthansa Cargo office.

LH-05 The transport of the following dog breeds (Exception: Dogs from 3 month up to 6 months) is allowed only in containers according to IATA CR ~~821~~ with additional reinforcements ~~(Exception: Dogs from 3 month up to 6 month):~~

- Frame must be constructed by using min. 25x25mm wooden or steel beams.
- The kennel must be made of solid wood (min. 12mm) and be bolted or screwed together.
- If the door is fully ventilated by a welded wire mesh (thickness 2.5mm), an additional layer must be installed.
- Ventilation holes should be covered with welded wired mesh.
- Backing doorstops must be installed to protect the door from being pulled into the kennel or pushed out of the kennel.
- A locking mechanism which can be secured by a cable/zip tie must be installed. The mechanism must avoid accidental opening of the kennel.
- Handles must be installed on both long sides of the kennel.

OS-01 Live animals travelling with passengers onboard Austrian Airlines flights

Provided all necessary permits/certificates/ confirmed ticket (for passenger travelling with pet) are available and approved by the operator following classes of live animals may be accepted:

- Domestic animals (cats and dogs only) belonging to a passenger travelling on the same flight
- Animals shipped for a zoological research project
- Specially trained dogs (e.g., Rescue or drug-sniffing dogs, ~~drug-sniffing dogs~~) on the way to/from a rescue operation or training units
- Service animals

OS-02 Live animals shipped as cargo

Booking requests for transportation should be made via Lufthansa Cargo. The following classes of live animals may be accepted:

- Domestic animals
- ~~• Animals subject to protection of species shipped between zoos and zoological gardens~~
- ~~• Animals shipped for a zoological research project~~
- Mice and rats shipped for scientific purposes
- Specially trained dogs (e.g., ~~rescue~~ Rescue or drug-sniffing dogs, ~~drug-sniffing dogs~~) on the way to/from a rescue operation or training units.

Following species will not be accepted for carriage:

- All ~~animals-wild-caught~~ animals in the wild

- Whales, dolphins, elephants, squirrels, bats
- ~~Frogs, toads, d~~Day old poultry
- [Prarie dogs ex USA/Africa](#)
- [Teacup dogs](#)
- Poisonous and dangerous animals
- Animals deemed to emit offensive or repugnant odors.

Following animals/species will only be accepted on request:

- [Animals shipped for zoological research projects](#)
- Fish with a single packaging weight of >50 Kg
- Marine mammals
- Bird shipments exceeding 5 animals

OS-03 ~~Restrictions to OS-01 and OS-02~~

With regard to a safe and welfare transportation of the animal ~~the acceptance is restricted,~~ [the following must be adhered](#) to:

- Animals which are ~~not~~ pregnant [must not be accepted for carriage](#).
- Weaned puppies/kittens ~~with~~ [must be](#) a minimum age of ~~at least~~ 12-weeks
- [Animals intended for laboratory purposes must not be accepted for carriage \(except mice and rats shipped as cargo\)](#)
- Brachycephalic dog [and cat](#) breeds (snub/pug nosed) [are not permitted for transport in cargo holds, except for confirmed service animals. must be shipped in a kennel that is 1 size larger than normal.](#) ~~The kennel must have ventilation on 4 sides.~~ [The following breeds are considered as being brachycephalic:](#)

OS-04 ~~Austrian Airlines will accept the following breed of dogs (and mixes thereof) only with cages as per CR82 (no modified rigid plastic pet containers are allowed)~~ The transport of the following dog breeds (Exception: Dogs from 3 month up to 6 months) is allowed only on containers to IATA CR1 with additional reinforcements:

- Frame must be constructed by using min. 25x25mm wooden or steel beams.
- The kennel must be made of solid wood (min. 12mm) and must be bolted or screwed together.
- If the door is fully ventilated by a welded wire mesh (thickness 2.5mm), an additional layer must be installed.
- Ventilation holes should be covered with welded wire mesh.
- Backing doorsteps must be installed to protect the door from being pulled into the kennel or pushed out of the kennel.
- A locking mechanism which can be secured by a cable/zip tie must be installed. The mechanism must avoid accidental opening of the kennel.

Changes to variations TK01-05 submitted for TK-Turkish Cargo

TK-01 List of animals and their objects that are strictly forbidden for carriage on TK flights:

- Interline transfers of live animals from other operators to Turkish Airlines are not accepted
- Laboratory/Experimental animals
- Dead animals
- Infected live animals
- Pregnant animals
- Puppies and kittens less than -10 weeks of age
- ~~Suckling young puppies and kittens with Nursing females~~
- All poisonous/[venomous](#) animals (e.g., scorpion, some varieties of frog, snake, spider etc.)
- ~~Raw and/or processed objects and remains (including hunting trophies, ivory) of live animals listed under IATA Live Animals Regulations Manual, Chapter 6, CITES Appendix I, shall not be accepted for carriage~~
- Shark fins are not accepted for carriage
- Restricted potentially dangerous dog species:
 - American Staffordshire terrier
 - American Pit Bull terrier
 - Dogo Argentino
 - Fila brasileiro
 - Japanese Tosa
 - Pitbull terrier
 - American Bully
 - Any mixed breed of above breeds of dog or their hybrid

TK-02 List of live animals that can be accepted for carriage in TK flights under certain conditions;

- Primates (monkey, gorilla, chimpanzee, etc.) can be accepted for carriage only if the shipper or agent certifies in writing on letterhead that the animals were born and bred in captivity,

AND

They are shipped between qualified zoological gardens/societies/organizations, recognized wildlife protection centers and rehabilitation centers for conservation or breeding purposes.

- Rodents (e.g., squirrel, rabbit, beaver, mouse, rat, hamster and Chinchilla etc.) can be accepted for carriage only when the containers containing rodents must be specifically rigid and resistant to animal gnawing.

- Endangered species listed under CITES Appendix I can be accepted for carriage only if the shipper or agent certifies in writing on letterhead that the animals were born and bred in captivity,

AND

They are shipped between qualified zoological gardens/societies/organizations, recognized wildlife protection centers and rehabilitation centers for conservation or breeding purposes.

[•Hunting trophies of CITES species listed under CITES appendix I, II and III which are carried on Turkish Airlines need to be accompanied by permits and certificates approved in accordance with international CITES regulations.](#)

- Live animals known to produce offensive odors can be accepted for carriage only on freighters. (Sheep, goat, bull, musk oxen, mustelines (mustelidai-marten), weasel and species (ferret-weasel), minks, shunks).

Puppies between 2.5 (two and a half) months and 6 (six) months can be accepted for carriage in accordance with the CR1 container requirements.

TK-04 Snub nosed dogs and cats can only be accepted for carriage in TK flights under below mentioned conditions:

- The cage must be one size larger than the size stated on cage instructions
- The cage must have ventilation areas on four (4) sides of it
- “Indemnity Letter” must be submitted by the sender
- The temperature at both the origin and destination must be below 27°C

TK-05 Animals specific to Türkiye and which are also fully protected can only be carried with prior approval from "Ministry of Food Agriculture and Livestock of Türkiye" (e.g., Ankara cat ([Turkish Angora Cat](#)) and Van cat ([Turkish Van Cat](#)), Tiftik Goat ([Angora Goat](#)) and Sivas Kangal dog ([Kangal Shephard Dog](#)). etc.).

Changes to variation WYO3 and WY1 1 for WY-Oman Air

WY-03 Live animals shipments must always be accompanied by ~~a health certificate~~ the following documents:

1. Import permit (if required)
2. Health certificate
3. Vaccination certificate
4. Pet passport (if applicable)
5. Tick & Tapeworm certificate (if applicable)
6. Microchip certificate (if applicable)

It is the shipper's responsibility to ensure that the required documents conform to the origin, transit & destination regulatory requirements. Oman Air will not be liable for refusal of the Live Animals at the point of origin, transit, or destination by the respective authorities or the consignee at the destination. Shipper will be responsible for all charges to repatriate the Animal back to the origin airport and is obliged to clear the shipment once returned.

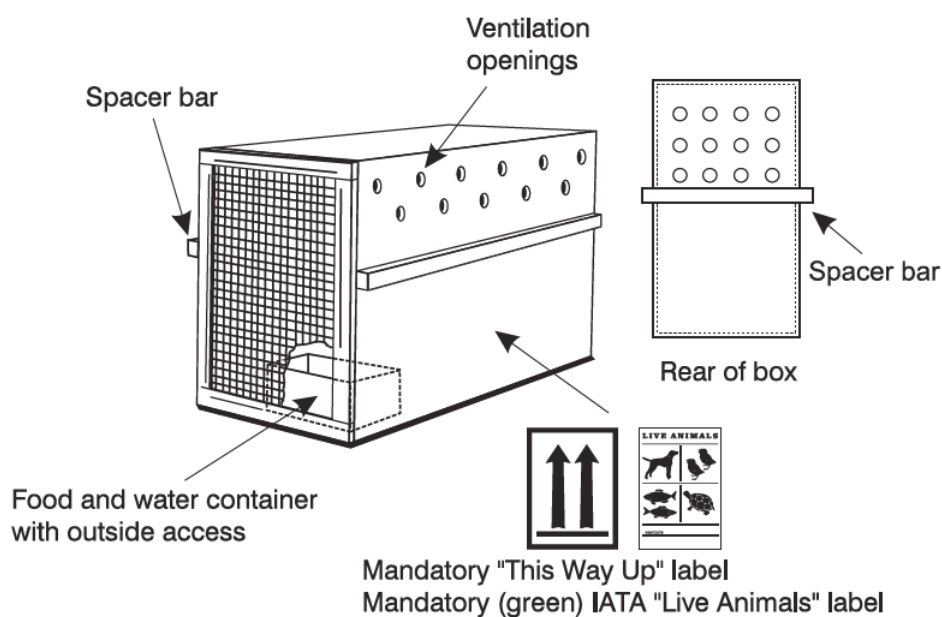
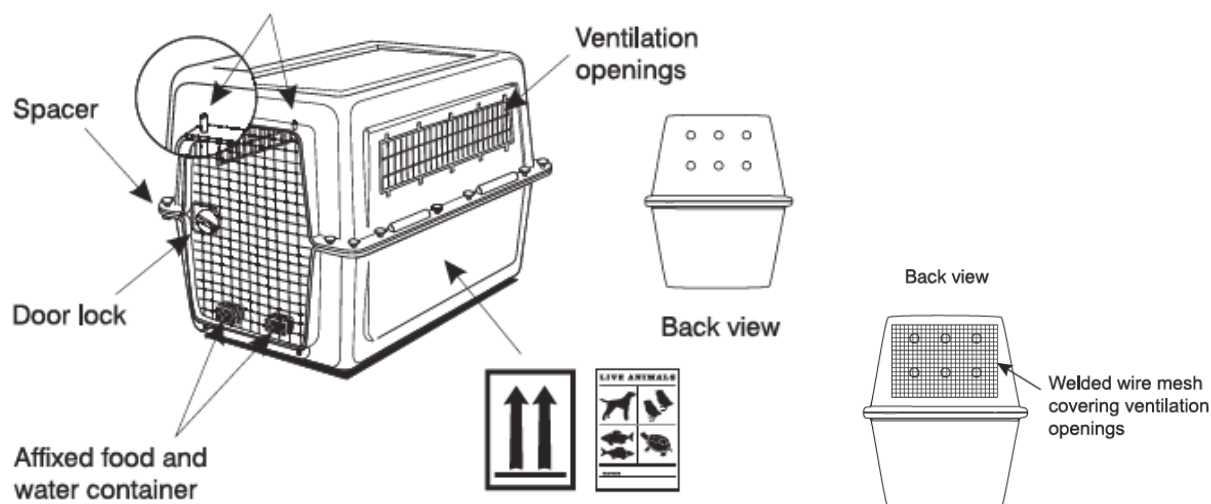
